## Welcome to the Pit

Hello and welcome to the first ever issue of "News from the Pit", a monthly newsletter from the Arizona Poison and Drug Information Center (AzPDIC) that focuses on all things envenomation related.

#### Who are we?

We're your friendly neighborhood poison center! AzPDIC is made up of board-certified medical and clinical toxicologists, as well as pharmacists who are board-certified as Specialists in Poison Information (SPIs).

#### Why are we starting this?

About two years ago we started a massive internal review dating back to 1999 for every rattlesnake envenomation case we were consulted on. This review yielded over 2,000 clinically relevant exposures that required hospitalization and antivenom. To provide some context, the clinical trials for the two current crotalid antivenoms contained a combined 156 patients. Currently we have more than 20 research projects in various stages of development as a result of this review. The goal of this newsletter is to stimulate conversation, spread awareness, and discuss challenges with everything from avoiding snake encounters to clinically managing a life-threatening envenomation.
